

# Founding Treaty of the International Confederation of Free Nations

## Preamble

We, the representatives of free nations, recognizing the principles of international law, the sovereignty, independence and cultural heritage of our peoples, unite in a spirit of solidarity and mutual cooperation. We found this confederation on the principles of peace, democratic values and the protection of human rights, with the aim of jointly resisting repression and globalist pressures threatening our sovereignty.

## Article 1 - Establishment of the Organization

We hereby establish the International Confederation of Free Nations (hereinafter referred to as the "Confederation"). The Confederation is established by the transformation and expansion of the International Conference of Free Nations, which reflects its transition from a discussion forum to a permanent international organization. The Confederation is an international organization based on the principles of voluntariness, cooperation and mutual support. The Confederation has legal personality in accordance with international law and may conclude international agreements.

## Article 2 - Objectives of the Confederation

Protection of the sovereignty and cultural identity of member states and peoples. Promotion of linguistic and cultural cooperation between member states. Organization of scientific and educational cooperation. Economic and infrastructural cooperation on the principle of mutual benefit. Coordination of activities to promote peace, democracy and human rights. Promotion of ecological and sustainable solutions for the benefit of the Member States.

## Article 3 - Membership

Sovereign states or nations that undertake to comply with the principles of this Treaty may become members of the Confederation. The General Assembly decides on the admission of new members by qualified majority. Membership is voluntary and any member may withdraw by submitting an official notification.

## Article 4 - Organizational structure

General Assembly - the highest decision-making body, where each member has an equal vote. Confederation Council - the executive body that ensures the implementation of the decisions of the General Assembly. Secretariat - the administrative center of the Confederation, ensuring communication and coordination. Statutory bodies - Representatives of the Member States and nations who are authorized to act on behalf of the Confederation and carry out its strategic management. Audit body - an independent commission responsible for overseeing the financial and administrative operations of the Confederation in order to ensure transparency and compliance with the statutes.

## Article 5 - Financing

The Confederation shall be financed through voluntary contributions from Member States, organisations and individuals. The Confederation may also obtain funding from grants and donations

in accordance with its objectives. Any use of the funds shall be subject to transparent control and audit by the control body.

#### Article 6 - Dispute resolution

Any disputes between Member States shall be resolved peacefully through diplomacy and mediation mechanisms. In the event of disagreement, the dispute may be submitted to the independent arbitration body of the Confederation.

#### Article 7 - Final provisions

This founding treaty shall enter into force upon ratification by a minimum of three Member States. The treaty may only be amended with the consent of a majority of Member States. In witness whereof the undersigned parties agree to the above conditions, we hereby sign this document. The motto of the Confederation: "Tradition unites us, freedom strengthens us."

### Statutes of the International Confederation of Free Nations

#### Article I – Introductory Provisions

These Statutes (hereinafter referred to as the “Statutes”) govern the functioning of the International Confederation of Free Nations (hereinafter referred to as the “Confederation”) in accordance with international law, the principles of sovereignty and respect for human rights. The Confederation is an international organization based on voluntariness, cooperation and mutual support, the purpose of which is to protect the sovereignty, cultural identity and democratic principles of all member entities. The Statutes follow on from the Founding Treaty and constitute the internal legal framework of the Confederation.

#### Article II – Legal Status and International Obligations

The Confederation is a subject of international law, with the right to conclude international agreements and treaties in accordance with the principles of the UN Charter and other international documents. Member States and peoples retain their sovereignty, while undertaking to respect the common obligations and standards set out in these Statutes. The Confederation is founded on the principles of transparency, the rule of law, equality and non-discrimination of all members.

#### Article III – Membership

Members of the Confederation may be sovereign states, nations or other subjective entities that voluntarily accept these Statutes and undertake to abide by their provisions. The admission of new members is subject to the decision of the General Assembly, with each member having one vote regardless of size or geographical location. Membership is voluntary and may be terminated in accordance with the provisions on withdrawal, while respecting the principles of international law.

#### Article IV – Bodies of the Confederation

General Assembly: The highest body of the Confederation, which includes all members. It decides on fundamental issues, approves amendments to the Statutes and the strategic direction of the organization.

Confederation Council: The executive body responsible for implementing the decisions of the General Assembly. It is composed of representatives whose selection is carried out in a transparent manner with due regard to regional and cultural diversity.

Statutory bodies: Bodies authorized to act on behalf of the Confederation, including the Presidency or President, who have the authority to represent the organization in international relations. Their competences and responsibilities are defined in detail in the internal regulations.

Audit body: An independent commission composed of experts that oversees the financial, administrative and organizational operations of the Confederation. The task of the audit body is to ensure compliance with the statutes and the principles of transparency in all activities of the Confederation.

#### Article V – Financing

The Confederation is financed through voluntary contributions from member entities, donations, grants and other financial sources that are in accordance with international law. All financial resources are used to fulfill the objectives and tasks of the Confederation and their use is subject to strict transparent control by the audit body. Financial operations must be carried out in accordance with international financial norms and standards of transparency.

#### Article VI – Dispute Resolution

Disputes between member entities arising in connection with the interpretation or implementation of the Statutes shall be resolved first through dialogue and international diplomacy. If no satisfactory solution is reached, the dispute may be referred to an independent arbitration body, which shall decide in accordance with international law. All decisions on dispute resolution shall be final and binding on all parties.

#### Article VII – Final Provisions

These Statutes shall enter into force on the date of their approval by the General Assembly and the entry into force of the Founding Treaty. Any amendments or supplements to the Statutes may only be adopted on the basis of a decision of the General Assembly with the consent of a majority of the members. In the event of the dissolution or reorganization of the Confederation, international legal norms and the rights of the member entities shall be respected. These Statutes constitute the internal legal framework for the functioning of the Confederation in accordance with international law and provide a clear structure for the administration, financing and resolution of disputes within the organization.
